All athletes traveling out of Province or to the USA for competition and or training must provide their coach with proof of valid out of province or out of country medical insurance prior to leaving.

_____ **International Competitor** – Nordic Combined and Ski Jumping activities - \$175.00
(includes Out-of-Country Accident Insurance that is mandatory for FIS Competitions)

Choose One: _____ Ski Jumping or _____ Nordic Combined

All athletes competing in FIS sanction events must be covered by Canadian Athlete Insurance Program (CAIP) through Ski Jumping Canada and Nordic Combined Ski Canada. Athletes will be billed \$35.00 per week for each week or partial week that they are out of the country (some exceptions may apply). There is no athlete subsidy applied to this bill.

Athletes with an International Competitors license will be required to complete a Medical Consent form.

_____ **2nd International Competitor** – Athletes that already hold an International Competitor Card in Ski Jumping and require an International Competitor Card in Nordic Combined (or vice versa) will be charged \$50.00 at the time the other card is requested, or if they require it for the full year, they will be invoiced for \$225.00 for two cards.

Note: Domestic and International Competitor fees will be invoiced.

COLLECTION OF PERSONAL INFORMATION

CANADIAN SNOWSPORTS ASSOCIATION (CSA), NORDIC COMBINED SKI CANADA (NCSC) AND SKI JUMPING CANADA (SJC) (collectively, the "**Organizations**" and each of the Organizations individually are the "**Organization**") in general collect, use and disclose Athlete Information in order to provide our athletes with our services. More specifically, the Organizations collect, use and disclose your personal information for the following purposes: (i) to assess whether the Athlete meets the qualifications for competition, (ii) to compile a list of all Athletes for purposes of communicating to them and their parents about Organization activities, meetings,

competitions, competition criteria, celebrations and events hosted by the Organization or affiliated organizations in the ski jumping and nordic combined communities in the Province and internationally and for fundraising purposes; (iii) to maintain records for each Athlete for purposes of developing individual training plans; (iv) to respond to an emergency medical situation; and (v) for such other purposes as agreed between the Board of the Organization governing the Athlete and the Athlete and parent, from time to time.

The Organizations will collect, use and disclose only that personal information necessary for the purposes that have been identified. The Organizations may disclose your personal information amongst themselves for the purposes listed herein. To the extent that an Organization is required to share your personal information with any of the Organizations such disclosure shall be done in accordance with the privacy policy of the Organization which originally collected your personal information.

BY SUBMITTING PERSONAL INFORMATION TO ANY ONE OF THE ORGANIZATIONS OR ANY OF THEIR SERVICE PROVIDERS AND AGENTS, YOU AGREE THAT THE ORGANIZATIONS AND ANY OF THEIR SERVICE PROVIDERS AND AGENTS MAY COLLECT, USE AND DISCLOSE SUCH PERSONAL INFORMATION AS PERMITTED OR REQUIRED BY PRIVACY LAWS. Subject to legal and contractual requirements, you may refuse or withdraw your consent to certain of the identified purposes at any time by contacting the Organization's Privacy Officer as listed on the Organization's website. If you refuse or withdraw your consent, we may not be able to provide you or continue to provide you with certain services or information, which may be of value to you. If you provide any one of the Organizations or any of their service providers and agents with personal information of another individual, you represent that you have all necessary authority and/or have obtained all necessary consents from such person to enable us to collect, use and disclose such personal information for the purposes set forth above.

Associated Risk

The Athlete acknowledges that there are physical risks associated with Nordic Combined and Ski Jumping activities (INCLUDING THE RISK OF SEVERE OR FATAL INJURY TO THE ATHLETE OR OTHERS) including but not limited to: (i) bruising and sprains, including bruising to lungs; (ii) joint disruption and injuries to knees; (iii) neck and spinal injuries which could result in paralysis in rare and extreme cases; (iv) concussions and injuries to the head; (v) shoulder injuries; and (vi) fractures to lower extremities.

It is further acknowledged by the Athlete that there may be risks associated with Nordic Combined and Ski Jumping activities, or any other activity that are not known at this time and not foreseeable.

Release of Liability

In consideration of the Releasees allowing the Athlete to register and permitting the Athlete to participate in the Releasees' events, sports, and any related activities, the Athlete agrees:

- To be solely responsible for any injury, loss, or damage which the Athlete may sustain through participation with the Releasee, **even though such injury, loss, or damage may be caused by the negligence of the Releasee;**
- To hereby exempt, waive, and release the Releasees from any liability for any and all claims, rights, and causes of action that the Athlete or his heirs, executors, administrators, and representatives may have, including but not limited to wrongful death caused by negligence, personal injury, or property damage, **even though such claims may be caused by the negligence of the Releasees.**
